2. The item offered for disposal is on "As is Where is AND What is Basis" without any guarantee.
3. The items are listed in Annexure-A with this documents.
4. The tenderer may inspect the item on any working day between 10.00AM to 01.00PM to satisfy themselves about the quality and condition of the item before submitting the tender.
5. The item shall be sold to the highest tenderer.
6. The offer value should be clearly quoted in tender for both in figures and in words exclusive of any taxes and duties. Taxes and duties that may be levied by the Govt will be extra as applicable.
