2. The make,model and technical specification of the items to be installed shall be mentioned clearly and item wise rates and labour charges shall be quoted separately. However, the total cost for supply and installation of devices inclusive of all taxes be given.

The sealed envelope should be superscribed "**QUOTATIONS FOR SUPPLY AND INSTALLATION CCTV CAMERAS AT OFFICE BUILDING OF EPFO, KOZHICODE (CALICUT)**" and addressed to Regional Provident Fund Commissioner, Calicut on the above mentioned office address. **The quotation should reach this office on or before 21.03.2016 at 4 p.m.** The parties may also drop their sealed quotations in the box placed in Administration Section.
